Notice is hereby given that the UPPER PLATTE RIVER SOLID WASTE DISPOSAL DISTRICT, (hereinafter called Owner) will receive Bids for the UPRSWDD - Recycling Baler, Saratoga, Wyoming.

The Owner will receive sealed bids (no faxed or emailed bids) at the Town of Saratoga, Town Hall, PO Box 486, 110 E. Spring Ave, Saratoga, WY 82331, until 2:00 P.M. on Wednesday, March 22, 2017, at which time bids will be publicly opened and read aloud. No bids will be considered which are received after the schedule time. All bids will be on separate forms and in sealed envelopes clearly marked with the name of the project: "UPRSWDD - Recycling Baler".

The baler shall include: One (1) New Wide Mouth Horizontal Recycling Baler that produces a standard 60" mill size bale. Must include: full penetration ram, adjustable shear blade, full bale and advance warning indicators, auto cycle

with photocell, start up alarm and light, open top style Anderson hopper, 20 HP motor, 8" cylinder, hydraulic door latch, oil heater, and must be manufactured in USA. Price to include delivery, start up and installation.

The Owner may reject any and all Bids and reserves the right to waive minor irregularities in

any Bid. Each Bid must be accompanied by Bid Security (check, cashier's check, certified check, bond, Irrevocable Letter of Credit or money order) payable to the Owner for 5% of the total amount of the Bid. Cash deposits, personal checks or company checks (unless certified) will not be accepted. If bid is more than \$150,000.00, the Bid Security must be in the form of bid bond secured by a surety or guaranty company authorized to do business in the State of Wyoming. Bid Security shall be forfeited to the Owner as liquidated damages if the Bidder is awarded the Contract and fails to enter into an Agreement with the Owner within thirty (30) days from his notification in accordance with Wyoming Statute §15-1-113. Bid Security of unsuccessful bidder will be returned promptly.

All Bids shall remain open for sixty (60) days after the day of the Bid opening.

The successful Bidder shall perform the Work and furnish a Performance Bond and a Payment Bond, each in the

amount of 100% of the contract price with a corporate surety approved by the Owner. The Contractor shall guarantee all materials and equipment furnished and work performed for a period of one year from the date of final acceptance. The Performance Bond shall remain in full force and in effect through the guarantee period.

The Notice to Proceed shall be issued within thirty (30) days of the execution of the Agreement by the Owner. If the Notice to Proceed is not issued within this period, this period may be extended by mutual agreement between the Owner and the Contractor. If the Notice to Proceed has not been issued within the thirty (30) day period or within any mutually acceptable extension thereof, the Contractor or the Owner may terminate the Agreement on written notice to the other party, and in such case, there shall be no liability under the Agreement or otherwise on the part of either party.

Contracts will be awarded to the lowest Bidder who has met the minimum requirements and who is

determined to be responsible in the sole discretion of the governing body.

Resident Wyoming laborers, workmen and mechanics shall be used upon all work in this contract whenever possible.

Pursuant to W.S. 16-6-106, "preference is hereby given to materials, supplies, agricultural products, equipment, machinery and provisions produced, manufactured, supplied or grown in Wyoming, or supplied by a resident of the state, quality being equal to articles offered by competitors outside of the state."

A pre-bid meeting will be held on March 15, 2017 at 2:00 P.M. at the Saratoga Landfill Transfer Station, 44 Pennock Mountain Road, Saratoga, WY 82331. Attendance is not mandatory but is recommended.
