The work is generally described as:

Installation of luminaires and security cameras and associated equipment in the aircraft parking apron area.

All bids must be accompanied by a Cashier's Check, a Certified Check or a Bid Bond in the amount equal to not less than ten percent (10%) of the total bid amount for all schedules, payable to the order of the Town of Saratoga, Wyoming as liquidated damages in the event said successful bidder shall fail or refuse to execute the contract

Preference will be given to materials, supplies, equipment, machinery and provisions produced, manufactured, supplied or grown in Wyoming, quality being equal to articles offered by competitors outside of the state.

Preference will be given to Wyoming bidders. The contract shall be awarded to the responsible resident making the lowest accepted proposal, if such resident's proposal is not more than 5% higher than that of the lowest responsible non-resident bidder.
