MINUTES OF A REGULAR MEETING OF THE SARATOGA TOWN COUNCIL HELD JANUARY 2, 2018 AT 6:00 P.M. IN THE COUNCIL CHAMBERS OF THE SARATOGA TOWN HALL

Mayor Ed Glode called the meeting to order at 6:00 p.m.

Members present were Councilman Will Faust, Councilwoman Jennie Lou Garland and Councilman Richard Raymer. Councilman Steven Wilcoxson was absent from the meeting.

APPROVAL OF AGENDA: Councilman Faust made a motion to approve the Agenda as presented.

Councilwoman Garland seconded and the motion carried.

APPROVAL OF THE MINUTES: Councilman Raymer made a motion to approve the minutes of the December 19, 2017 meeting as presented. Councilwoman Garland seconded and the motion carried unanimously.

APPROVAL OF THE BILLS: Treasurer Samuel Flohr read the following bills for approval: Accounts Payable: \$56,118.39; Payroll and FICA for pay period 12/26/2017 in the amount of \$54,055.03; and manual checks with December liabilities and quarterlies in the amount of \$62,677.33 for a total of \$172,850.75.

Councilman Faust made a motion to pay the bills in the amount of \$172,850.75. Councilwoman Garland seconded and the motion carried unanimously.

REPORTS FROM DEPARTMENTS:

Town Hall: Councilman Faust made a motion to designate the Rawlins National Bank, Bank of the West and Bank of Commerce as the official depositories of the Town of Saratoga. Councilman Raymer seconded and the motion carried unanimously.

Councilman Faust made a motion to designate the Saratoga Sun and Rawlins Daily Times as the official newspapers of the Town of Saratoga. Councilman Raymer seconded and the motion carried unanimously.

Mayor Glode read Resolution 2018-01 for financial assistance from the Wyoming Department of Transportation to help with the cost of cleaning and maintaining the storm sewers, sweeping and washing all streets and highways and for snow removal from streets and highways within the town's corporate limits.

Councilman Faust made a motion to approve Resolution 2018-01, a Resolution for financial assistance from the Wyoming Department of Transportation with permission for the Mayor to sign. Councilwoman Garland seconded and the motion carried unanimously.
