**NOTICE OF PUBLIC HEARING PROPOSED LITTLE MEDICINE BOW WIND PROJECT CARBON COUNTY, WYOMING**

Little Medicine Bow Wind S LLC seeks to notify the public, local communities, neighboring landowners, and all mineral rights holders in the area of a proposed wind project in Carbon County, Wyoming. The Little Medicine Bow Wind Project is proposed to be located entirely on state lands contained in TOWNSHIP 26 NORTH, RANGE 79 WEST SECTION 36 and TOWNSHIP 25 NORTH, RANGE 78 WEST SECTION 16. Little Medicine Bow Wind S LLC is developing the Little Medicine Bow Wind Energy Project, which will be located on approximately 981 acres of land north of the Town of Medicine Bow, Wyoming in Carbon County, Wyoming. The Little Medicine Bow Wind Project is a proposed commercial wind energy facility of approximately 40 megawatts in size that will contain approximately 13 wind turbine generators and related facilities including two substations, internal access roads, and an electrical collec-

tion system. The Project also includes an overhead 230 kilovolt transmission line located within a Wyoming Department of Transportation right-of-way for Wyoming State Highway 487 to join the two state parcels together and connect with existing transmission lines in the area. Little Medicine Bow Wind S LLC has submitted an application for a Conditional Use Permit (the "Application") to the Carbon County, Wyoming Department of Planning & Development to permit the Little Medicine Bow Wind Energy Project. Hearings in relation to the Application for a Conditional Use Permit from Carbon County, Wyoming for the proposed Little Medicine Bow Wind Energy Project are scheduled as follows. The Carbon County Planning & Zoning Commission will hold a public meeting on Monday, April 30, 2018, beginning at 11:00 A.M., Carbon Building, Room 368, located at 215 West Buffalo Street, Rawlins, Wyoming. The Carbon County Board of County Commissioners' hearing will take place on Tuesday, June 5, 2018, beginning at 1:30 P.M., Carbon County Courthouse, Commissioners'

Room, located at 415 West Pine Street, Rawlins, Wyoming.
