ORDINANCE NO. 861

AN ORDINANCE TO AMEND CHAPTER 1.12.01(C) OF THE MUNICIPAL CODE. THE TOWN OF SARATOGA, CARBON COUNTY, STATE OF WYOMING, AUTHORIZING THE TOWN OF SARA TOGA TO AMEND THE MUNICIPAL CODE DUE TO CHANGING STATE COURT FEES.

BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF SARA TOGA, CARBON COUNTY, WYOMING:

Article 1.12.01(C)

Section 1.12.01(C) is hereby amended to read as follows:
C. Costs. In addition to any fine or incarceration imposed under this section, the following shall be imposed upon any person guilty of a violation of a town ordinance:

1. A court automation fee of forty dollars (\$40.00), or such other amount set by Wyoming State Statute;
2. An indigent civil legal services fee often dollars (\$10.00), or such other amount set by Wyoming State Statute;
3. A fee of not more than ten dollars (\$10.00), or such other amount set by Wyoming State Statute, for any matter in which a trial is held; and
4. Any other costs permitted by law.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF SARATOGA, CARBON COUNTY, STATE OF WYOMING, THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS APPROVAL,

PASSAGE, ADOPTION AND PUBLICATION.
