As allowed by Section 41-4-312, any person claiming a water right interest in the same sources of supply to which the below advertised proofs refer may inform the Water Division Superintendent of his desire to contest the rights of the person or persons seeking adjudication. The statement of contest shall be presented within fifteen days after the closing of the public inspection and shall state with reasonable certainty the grounds of the contest. The statement must be verified by the sworn affidavit of the contestant, his agent or attorney. If no contest is initiated, the advertised proofs will be submitted to the State Board of Control for consideration during its meeting beginning on November 14, 2016 with the Division Superintendent's recommendation that certificates of appropriation be issued.

Objectives/Policy Statement

The Town of Saratoga has established a Disadvantaged Business Enterprise (DBE) program in accordance with regulations of the U.S. Department of Transportation (DOT), 49 CFR Part 26. The Town of Saratoga has received Federal financial assistance from the Department of Transportation, and as a condition of receiving this assistance, the Town of Saratoga has signed an assurance that it will comply with 49 CFR Part 26.

It is the policy of the Town of Saratoga to ensure that DBEs as defined in Part 26, have an equal opportunity to receive and participate in DOT-assisted contracts. It is also our policy:

To ensure nondiscrimination in the award and administration of DOT-assisted contracts;
To create a level playing field on which DBEs can compete fairly for DOT-assisted contracts;
To ensure that the DBE Program is narrowly tailored in accordance with applicable law;

To ensure that only firms that fully meet 49 CFR Part 26 eligibility standards are permitted to participate as DBEs;
To help remove barriers to the participation of DBEs in DOT assisted contracts;

To promote the use of DBEs in all types of federally-assisted contracts and procurement activities;

To assist the development of firms that can compete successfully in the market place outside the DBE Program; and

To provide appropriate flexibility to recipients of Federal financial assistance in establishing and providing opportunities for DBEs.

The Town Council's representative to the Saratoga Airport Board has been delegated as the DBE Liaison Officer. At the time of this submittal, the representative is Mr. Richard Raymer. In that capacity, Council

Representative Raymer is responsible for implementing all aspects of the DBE program. Implementation of the DBE program is accorded the same priority as compliance with all other legal obligations incurred by the Town of Saratoga in its financial assistance agreements with the Department of Transportation.

The Town of Saratoga has disseminated this policy statement to the Town Council and all of the components of our organization. We will distribute this statement to DBE and non-DBE business communities that perform work for us on DOT-assisted contracts as part of the contract documents for eligible projects.

The proposed goals for projects undertaken in the goal period FY 2017 through 2019 and the rationale are available for inspection during normal business hours at the Airport for 30 days following the date of this notice. The Town of Saratoga will accept comments on the goals for 45 days from the date of this notice.

Indians, FFA, opening day and 55 Alive

100 Years Ago October 5, 1916 Indians Holding Their Own

In spite of the mistakes which mark the history of the relations of the white man with the Indian, the remnants of the original American stock are providing themselves capable of taking an honored place as citizens of the nation which has succeeded to their birthright. In Oklahoma the Indian is now a citizen and there is no activity in which white men excel that is not marked by a comparable success on the part of the Indian. It is now proposed ultimately to give all the Indians in the United States full American citizenship, and as the first remedial step to place the administration of Indian affairs beyond the control of politics by establishing a federal nonpartisan commission. In Oklahoma, thousands of full-blooded Cherokees, Chickasaws, Choctaws, Creeks and Seminoles are operating well-kept farms and supporting adequate and well-equipped schools. The Navajo Indian blanket industry last year reached a total of three-quarters of a million

dollars, and 60,000 Indian boys and girls were last year being educated in special schools conducted like our public schools. There are now 350,000 Indians in the United States and 25,000 in Alaska.

75 Years Ago October 2, 1941 'Future Farmers' Are Attending State Meet In Laramie This Week

Five members of Stewart McPhall Chapter, F. F. A., and their instructor, Lawrence Parker in charge of the high school Vo-Ag department, departed yesterday for Laramie to attend the State FFA contests being held this week. The Saratoga boys will take part in four contests, as follows: Stock judging-Allen Elliot, Winthrop Condict, Artlin Zieger, Nathan Irvin; poultry judging- Nathan Irvin, Winthrop Condict; agronomy judging-Allen Elliot, Winthrop Condict; farm mechanics- (rope, leather, rafters), Artlin Zeiger; (tool identification, soldering, tool sharpening), Dick Stockwell. The contest started this morning with livestock judging work under the supervision of the

University's animal production department. Hots, sheep, cattle, horses and dairy stock will be judged.

Tomorrow morning the agronomy contest will be held. William Riedl of the University agronomy department, will supervise the work. That afternoon the farm mechanics contest will take place. Dean R. D. Goodrich of the university will be in charge.

The poultry judging contest is slated for Saturday morning under the supervision of Mack O. North of the animal husbandry department.

Winners of the various contest will be announced Saturday night at the banquet at the Wyoming Union, and prizes will be awarded. A barbecue, sponsored by the University of Wyoming Ag club, will be held Thursday and the University stock farm. The local boys and Mr. Parker will return home Sunday.

50 Years Ago September 29, 1966 Deer, Antelope Hunting to Open Throughout Valley This Saturday

Deer and antelope hunters take to the field Saturday for

opening day of both seasons.

Two deer areas near Saratoga will open Oct. 1, with the Laramie River-Upper Platte River area to close Oct. 25 and the South Rawlins area No. 15 to close Oct. 20. Included in these areas is most of the valley from the state line to Highway 30.

An open season for the hunting of 300 antelope from Oct. 1 through Oct. 7 has been set by the game and fish department for the Sage Creek-Elk Mountain area. Generally, this area includes all of the valley from the state line to Highway 30.

Doyle Thompson, deputy game warden, said that generally the deer and antelope herds are in good shape in this area. However, dry, mild fall weather will make deer hunting difficult since most of the mulies are still in the forest.

Mr. Thompson urged all hunters to read and observe the rules, concerning big game animals, and especially regulations concerning proper tagging and hunting on private land without permission.

Donald Bielefield, district forest ranger, urged all persons hunting on the forest to exercise caution with fire because of the

dry conditions, and to avoid littering. He suggested that forest campers either place garbage and papers in the barrels provided at many camp grounds or take cans and similar litter home. "Please don't bury trash or leave it strewn around the forest," Mr. Bielefield said.

The 55 Alive driving course is for drivers 50 years and over. By state law, insurance companies must offer some type of discount for those drivers who have successfully completed the course. Contact your insurance agent to determine what benefits you will receive after completion. Cost of the course is \$8 per person to cover the cost of materials used in the class. According to Dick Ament, the local instructor, there are 13 percent less accidents among those who do not take it in that age group.
