### CONSENT AGENDA

Commissioner Espy moved to approve the consent agenda noting any item could be removed for separate action. Clerk Bartlett noted the consent agenda includes the June 6, 2023, and June 7, 2023, regular meeting minutes. Commissioner Johnson seconded and the motion passed unanimously.

### ELECTED OFFICIALS & DEPARTMENT HEADS

#### Public Health

Commissioner Johnson moved to approve the contract between Wyoming Department of Health Public Health Division in the amount of \$10,000.00 and Carbon County for the purpose of the County Health Officer in an amount of an additional \$9,600.00, and both for terms of July 1, 2023, through June 30, 2024. Commissioner Espy seconded and the motion passed unanimously. Commissioner Barkhurst moved to approve the Carbon County Public Health's Cash Handling Policy. Commissioner Espy seconded and the motion passed unanimously.

Commissioner Barkhurst moved to approve the Amendment Number One to the Agreement between Carbon County and Professional Consultative Examination Services Per Diem Use Agreement to update the previous agreement to include the following company name: Joppa Capital Ventures, Inc. d/b/a/ EverMed Exams. Commissioner Espy seconded and the motion passed unanimously.

Commissioner Espy moved to authorize the Chairman's signature on the Contract Between the Wyoming Department of Health, Public Health Division and Carbon County Health Department for a term of July 1, 2023, through June 30, 2024, totaling \$117,000.00 for the Public Health Response Coordinator. Commissioner Moore seconded and the motion passed unanimously.

#### Emergency Management

Commissioner Barkhurst moved to approve the Grant Award Agreement between WY Office of Homeland Security and Carbon County (21-HMGP-CAR-HM4535-3F) in the amount of \$44,583.32 and for a term of August 5, 2021, through July 31, 2025, for the purchase of early warning sign gauges. Commissioner Moore seconded the motion passed unanimously.

#### Sheriff

Commissioner Johnson moved to approve the Memorandum of Understanding between Carbon County and Carbon County School District #2 (CCSD2) for the School Resource Officer Program in which CCSD2 will provide financial contributions of \$40,000.00 annually to the Carbon County Sheriff's Office for salary and benefits and for a term that will remain in full force and effect until terminated by one of the parties upon 60 days written notice. Attorney Davis noted three changes requested by the school - removal of attorney signature lines, addition of a reference to the school board trustees and addition of language of a payment date and proration of the agreement. Commissioner Moore seconded and the motion passed unanimously.

#### Road & Bridge

Commissioner Espy moved to authorize any commissioner to sign paperwork with S&L Industrial for centerline striping of the Seminole Road after development and attorney approval. Commissioner Barkhurst seconded and the motion passed unanimously.

Commissioner Espy moved to approve the Chairman's signature on the Final Reconnaissance Reports for DMW Bridge over Muddy Creek (CR 702), FPX Bridge over Four Mile Creek (CR 603) and DMR Bridge over Third Sand Creek (CR3). Commissioner Moore seconded and the motion passed unanimously.

#### Fire

Commissioner Moore moved to approve the Chairman's signature on the 2023 Wildland Fire Management Annual Operating Plan developed by the Wyoming State Forestry Division. Commissioner Espy seconded and the motion passed unanimously.

#### Clerk

Commissioner Barkhurst moved to approve Amendment #1 to the Real Property Lease No 8-09274 between Carbon County Commissioners and State of Wyoming, Department of Administration and Information, General Services Division for office space rent for the Department of Family Services on the 3rd Floor of the Carbon Building. Commissioner Johnson seconded and the motion passed unanimously.

#### EXECUTIVE SESSION

Commissioner Espy moved to go into executive session at 10:01 a.m. with Clerk Bartlett, Ashley Mayfield Davis, Matt Webster, and Mike Newbrough to discuss personnel, potential litigation and other matters considered confidential by law. Commissioner

Moore seconded and the motion passed unanimously.

Commissioner Espy moved to come out of executive session at 10:45 p.m. noting no action was taken and that the minutes be signed and sealed. Commissioner Moore seconded and the motion passed unanimously.

#### Wyoming Downs

Commissioner Johnson moved to authorize the Chairman's signature on Resolution 2023-19, A Resolution Approving Wyoming Downs, LLC to Conduct Pari-Mutuel Wagering on Live Horse Racing, Historic Horse Racing, Simulcast Events and Rodeo Events Within Carbon County, Wyoming adding the property at 1602 Inverness Blvd in Rawlins known as the Peppermill. Commissioner Moore seconded and the motion passed unanimously.

Commissioner Moore left the meeting at 11:00 a.m. to represent the BOCC at the Transwest Express groundbreaking.

#### PUBLIC HEARING - Budget Amendment

Chairman Jones opened a public hearing at 10:59 a.m. to hear about a proposed Budget Amendment to departmental budgets for Fiscal Year 2023 and Clerk Bartlett noted the hearing was advertised in the Saratoga Sun on June 8. Gwynn outlined the amendments as follows: increase expenditures as follows - Commissioners by \$10,000 to cover increased dues to the WY County Commissioner's Association, Treasurer by \$1,500 to cover postcard reminders now contracted out of this budget, Utilities by \$26,977.59, Dixon Airport by \$10,000.00 primarily for fuel expense, Road & Bridge by \$10,000 primarily due to fuel costs from a bad winter, Outside Agencies by \$50,705.30 for the Carbon County Fire Protection District, and reduce reserves by \$109,182.89 to cover the above. In addition, the following special revenue funds: Fund 152 by \$3,575.00 as this was a new fund and Fund 284 the Sheriff's Search & Rescue fund by \$3,585.06 to cover Hagglund repairs from various searches.

Chairman Jones called for comments for or against the amendment. There being none, she closed the hearing at 11:02 a.m.

Commissioner Barkhurst moved to adopt Resolution 2023-23 - FY 2023 Budget Amendment Number One for departmental budgets. Commissioner Johnson seconded and the motion passed unanimously.

#### PUBLIC HEARING - C.U. Case #2023-03 - Union Telephone Company and BLM

Commissioner Johnson moved to untable C.U. Case File 2023-03, Union Telephone Company's request for a Conditional Use Permit. Commissioner Barkhurst seconded and the motion passed unanimously.

Chairman Jones opened a public hearing at 11:02 a.m. to hear Planning & Zoning C.U. Case #2023-03, Union Telephone Company's request for a Conditional Use Permit in the Ranching, Agriculture and Mining (RAM) Zone. The request is to permit telecommunications tower up to 155 feet tall and related facilities/equipment at the Midway Communications Site. The Site is located approximately 6.5 miles south of I-80 exit 235 and WY HWY 130 on the west side. Planning Director Sarah Brugger presented the case.

Chairman Jones called for comments for or against the case. There being no comments, she closed the hearing at 11:08 a.m.

Commissioner Espy moved that based on the recommendation of the Planning & Zoning Commission and staff to approve Resolution No. 2023-21, A Resolution of the Board of County Commissioners of Carbon County, Wyoming adopting the recommendation of the Carbon County Planning and Zoning Commission regarding Planning and Zoning C.U. Case #2023-03, Union Telephone Company's request for a Conditional Use Permit in the Ranching, Agriculture and Mining (RAM) Zone, located approximately 6.5 miles south of I-80 exit 235 and WY HWY 130 on the west side at the Midway Communications Site. Commissioner Johnson seconded and the motion passed with all voting for except Chairman Jones who voted against.

#### EXECUTIVE SESSION

Commissioner Espy moved to go into executive session at 11:27 a.m. with Clerk Bartlett, Ashley Mayfield Davis, Matt Webster, and Mike Newbrough to discuss personnel, potential litigation and other matters considered confidential by law. Commissioner Moore seconded and the motion passed unanimously.

Commissioner Espy moved to come out of executive session at 12:46 p.m. noting no action was taken and that the minutes be signed and sealed. Commissioner Moore seconded and the motion passed unanimously.

#### Commissioner Discussion

Commissioner Espy moved to waive the procurement policy to allow Buildings & Grounds to repair the electrical issue at the Courthouse. Commissioner Barkhurst seconded and the motion passed unanimously.

#### RECESS

The meeting was recessed, and Chairman Jones declared the meeting will resume June 21, 2023, at 8:30 a.m. Chairman Jones called the meeting to order at 8:30 a.m. on June 21, 2023, and the BOCC balanced the budget including the general fund and numerous special revenue funds.

#### ADJOURNMENT

Commissioner Espy moved to adjourn the meeting at 1:30 p.m. Commissioner Moore seconded and the motion passed unanimously.

## Grading Your Steak

The thought of a steak dinner can conjure up a variety of images in the mind.

A candle-light dinner on the patio with a loved-one. The sizzle of the meat and fat over an open fire while on a camping trip. A splurge at your favorite restaurant after a successful week. While the images may differ, the experiences are, hopefully, similar.

The smell of a steak just removed from a grill or skillet can be enough to make mouths water and stomachs growl. The serrated knife, cutting through the steak with ease lets you know that it is tender. Then, when that first bite hits the tongue, savory juices awaken the taste buds.

There are a variety of opinions

on how a steak should be cooked ranging from rare to medium-rare to well-done with ketchup. There are also different grades of steak. The United States Department of Agriculture (USDA) assigns different quality grades to beef, but most of what is available falls into three categories: prime, choice and select.

#### Fat is Your Friend

Just like with cooking a good hamburger, fat is your friend when it comes to steak. Especially when it comes to the marbling of a steak. This is just one aspect the USDA looks at when grading steak as they look at both fat content and distribution. Marbling refers to how fat is dispersed through

the lean portions of a steak. The white streaks of fat make a cut of beef look similar to marble, hence the term "marbling." When cooked, the fat and other connective tissue which contribute to the marbled look will break down or render and add flavor. The more marbling there is within the steak the better the flavor and texture of the steak as the fat self-marinates the cut of meat.

Prime beef is the highest grade given by the USDA and is typically served in restaurants and can be found in high-end butcher shops and grocery stores. According to "Meat Illustrated" by America's Test Kitchen, only about 2% of graded beef is considered prime. Prime cuts of beef are excellent for dry-

heat cooking such as broiling, roasting or grilling.

Choice beef, while high quality, has less marbling than Prime. These cuts are also flavorful and well-suited for dry-heat cooking. Steaks from the loin and rib portion of the beef cattle are going to be the most tender. Other cuts, which will have less marbling, are better suited for braising, roasting or simmering with some liquid.

Select beef has far less marbling than either Prime or Choice. While this grade of beef can also be tender, it will also lack some of the juiciness and flavor found in the higher grades. According to the USDA, only the tender cuts of Select beef should be cooked with dry heat. All other cuts should be marinated before

cooking or braised. A blind taste test by America's Test Kitchen of the three grades rendered what some may have already suspected. Prime was ranked first due to its tenderness, buttery texture and flavor. Choice was ranked second and, while it was still flavorful, was slightly tougher than prime. Select came in last, with a tough texture and little flavor.

#### What's up with wagyu?

Wagyu could be described as a "cut above the rest." The term wagyu is Japanese and wagyu beef historically comes from four breeds of Japanese cattle. Wagyu from Japan is carefully regulated and highly prized. Outside of Japan, the term is less regulated which leads to

American Wagyu. Most American Wagyu is a crossbreed of purebred Japanese wagyu and American Angus. Most American Wagyu is rated as prime due to its marbling and color. It may be daunting to decide to try and cook American Wagyu at home, especially on the grill. The trick is to be vigilant. The melting point of typical beef fat is 104 degrees Fahrenheit, but it is 77 degrees in American Wagyu. Because it doesn't take much, it is recommended to place an American Wagyu steak on direct heat for 2-3 minutes per side and then let it cook over indirect heat until it reaches 145 to 160 degrees Fahrenheit.
