Notification is hereby given to the public that the Saratoga Encampment Rawlins Conservation District (SERCD) has requested funding from the Federal Emergency Management Agency (FEMA) for a proposed flood mitigation and stream restoration project near the Town of Saratoga, WY. This notification is provided pursuant to the National Environmental Policy Act (NEPA), Section 106 of the National Historic Preservation Act (NHPA), Executive Orders 11988 – Floodplain Management, and Executive Order 11990 - Wetland Protection, and Federal agency implementation procedures described in 44 C.F.R. Part 9 and FEMA Directive 108-1. Funding from FEMA's Flood Mitigation Assistance Program will be utilized. The purpose of FEMA's mitigation program is to implement cost-effective mitigation projects that will reduce the overall risk to populations

The proposed project will stabilize the North Platte River within a channel reach that has a long history of instability. The project is in T17N R87W Section 13, at approximately latitude: 41.438119; and longitude: -106.791671. The project includes realignment of approximately 1674 linear feet of river the channel to more stable plan form, profile, and cross-sectional dimensions. These modifications are intended to significantly reduce the risk of an avulsion of the North Platte River at Boozer Creek through channel stabilization, floodplain connectivity, multi-stage channel, and in stream structures such as toewood and boulder constructed riffles. The Boozer Creek Ditch will not be directly reconnected to the North Platte River via culverts or headgates as part of this project. The flood mitigation measures installed in the past will be removed to establish a more permanent and natural-appearing riparian area. Areas for willow staking are also delineated in the design plan as long-term stability through vegetation will be promoted. The existing road and irrigation ditch will be reconnected to their existing alignments. Hydraulic modeling and analysis have demonstrated the project will reduce flooding potential in Saratoga and mitigate the impacts of a 100year flood to the Town's structures, facilities, and residents. Construction activities would be in accordance with all applicable federal, state and local laws, regulations and ordinances. This action requires SERCD to acquire a Floodplain Development Permit, and to comply with local floodplain ordinances and the National Flood Insurance Program regulations.

The President of the United States has issued Executive Orders that require Federal Agencies to focus attention on the environment and on human health and safety when considering the funding of an action. Executive Orders 11988 – Floodplain

Management and 11990 - Wetland Protection require federal agencies to avoid to the extent possible the long and short-term adverse impacts associated with the occupancy and modification of floodplains/wetlands and to avoid direct and indirect support of floodplain/wetland development wherever there is a practicable alternative. With this public notice, FEMA is informing the public that the proposed action will occur in areas that are mapped within the 100-year floodplain, as well as wetlands. Based on the purpose of the project, all practicable alternatives contain project features located in the floodplain and wetlands and are functionally dependent at their location according to project design considerations. Any impacts have been minimized to the extent possible. It is anticipated that long-term impacts to the floodplain and wetlands will be beneficial, with potential minor, short-term impacts during the construction process

Hydraulic modeling and analysis have determined that minor increases to water surface elevations will occur to specific areas of flood irrigated pasture lands located adjacent to the project area. Impacted landowners have been notified by the SERCD and have expressed no concerns with the proposed project. The above noted increases to water surface elevation will not impact any structures. To minimize impacts to wetlands, appropriate erosion and sediment control measures will be installed to control the discharge of pollutants from the construction site. Approximately 1.19 acres of wetlands were delineated within the project area. Any permanent wetland impacts will be mitigated onsite as part of the proposed stream restoration project. Impacts to jurisdictional wetlands will be addressed in compliance with Section 404 of the Clean Water Act. FEMA has also evaluated and addressed potential effects of the proposed project on threatened

and endangered species, and historic properties. A public comment period for the proposed project described in this notice will remain open for 15 days from date of publication. If no substantive comments are received, the proposed project may proceed no sooner than 15 days after the comment period closes.
