Reflections...

Shively Hardware Co. of Saratoga submitted the apparent low bid on a 48-passenger chassis for an activity bus to be used at Encampment. The local international dealer's bid was \$5,4000.30. Jacobs Equipment Co.'s bid was accepted for the body for the chassis. At the Ohio plant the cost would be \$4,646 and at the company's Mississippi plant coast would be \$4,400.

The motion read the take delivery from the plant which would be the cheapest delivery point. One other bid was received for the chassis and four additional bids were read by the board for the body. A 1959 International bus was sold to Hill Land and Livestock Co. for the bid received on the vehicle. The board instructed Zeiger Enterprises to repair the motor and place a heater in a 1970 Chevrolet panel to be used as a spare bus within the

district.

Houses and mobile homes owned by the district came under discussion, with the board voting to offer two houses lost in Hanna for sale at public bid and to trade in a 1964 mobile home on a new 2 bedroom trailer 14x60 feet and to sell another mobile home all located in Shirley Basin. The district's extensive building program has received final approval from the board of trustees. Opening bids of the \$2,225,000 project has been set for April 22 during the regular meeting of the board.

Other Business included: Granting Pat Bromley of Encampment permission to graduate at the end of the current graduate at the end of the current nine-week period. He has met all graduation requirements and plans to work and cited medical reasons for seeking early

graduation. He will receive his diploma with the class of 1974 in May.
