### PROPOSED AMENDMENT TO THE WYOMING CONSTITUTION TO BE VOTED ON AT THE GENERAL ELECTION NOV. 5, 2024

*Underlined words would be added to existing law. Words stricken through will be removed.*

A JOINT RESOLUTION to amend the Wyoming Constitution by providing for the assessment of residential real property as a separate property class for the purpose of taxation. *BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF WYOMING*, two-thirds of all the members of the two houses, voting separately, concurring therein:

**Section 1.** The following proposal to amend Wyoming Constitution, Article 15, Section 11 is proposed for submission to the electors of the State of Wyoming at the next general election for approval or rejection to become valid as a part of the Constitution if ratified by a majority of the electors at the election:

#### Article 15, Section 11. Uniformity of assessment required.

(a) All property, except as in this constitution otherwise provided, shall be uniformly valued at its full value as defined by the legislature, in ~~three (3)~~ four (4) classes as follows:

- (i) Gross production of minerals and mine products in lieu of taxes on the land where produced;
- (ii) Property used for industrial purposes as defined by the legislature; ~~and~~
- (iii) Residential real property; and
- (iv) All other property, real and personal.

(b) The legislature shall prescribe the percentage of value which shall be assessed within each designated class.

All taxable property shall be valued at its full value as defined by the legislature except agricultural and grazing lands which shall be valued according to the capability of the land to produce agricultural products under normal conditions. The percentage of value prescribed for industrial property shall not be more than forty percent (40%) higher nor more than four (4) percentage points more than the percentage prescribed for residential real property or more than forty percent (40%) higher nor more than four (4) percentage points more than the percentage prescribed for all other property other than minerals.

(c) Except as provided in this subsection the legislature shall not create new classes or subclasses or authorize any property to be assessed at a rate other than the rates set for authorized classes. The legislature may create a subclass of residential real property for owner occupied primary residences.

(d) All taxation shall be equal and uniform within each class and subclass of property. The legislature shall prescribe such regulations as shall secure a just valuation for taxation of all property, real and personal.

**Section 2.** That the Secretary of State shall endorse the following statement on the proposed amendment:

The adoption of this amendment would separate residential real property into its own class of property for purposes of property tax assessments. The amendment would authorize the legislature to create a subclass of owner occupied primary residences.

### September 12, 1974 50 Years Ago

## Donelan Resigns as Airport Manager

The resignation of L.D. Donelan as airport manager was accepted by the Saratoga Town Council during the regular meeting Sept. 4 in the Town Hall.

A letter from Mr. Donelan, who had been airport manager since 1946, was read by Mayor Sam Clark.

The letter said:

"This is my letter of resignation as airport Manager effective as of this date, Sept. 4, 1974."

"I have been Airport Manager since 1946 and enjoyed it very much. I feel that during my years a lot has been accomplished such as oiled runways, installation of unicom service, installation of aviation gasoline, lighted runways, and

numerous other things. Little did I think while I was up there grubbing sagebrush that I would see such a beautiful airport in Saratoga, one of the finest, if not the finest, in the State of Wyoming. So now I feel that since I have retired and I am gone a lot that someone else should take over, as new blood is always good for any

project."

"I think that Howard V.C. Davis would be a wonderful man for the job. He was built a beautiful Air Terminal and has the best equipment money can buy in the terminal. He has had lots of flying experience and now has a plane of his own based here. He is also encouraging several young

people to take up flying and has given several scholarships for flying lessons. I am sure he will continue to do lots of fine things for our airport. He has plenty of time, energy and the desire to continue improving the airport."

"I have talked to Gary Welton, the assistant airport manager, and he realized that he is too

busy to take over the duties as manager but would still like to remain as the assistant manager."

Mayor Clark asked Mr. Davis if he wanted the airport manager's position, to which Mr. Davis answered "no." The mayor then named Gary Welton as airport manager, which was approved by the Council.

G.R. Gould is busy remodeling the east room of his building on Bridge street, the former Central Garage, and has announced that he will soon open a barber shop in the room. He reports that new chairs and other equipment will be installed, and that he

## Big Game Season To Open Monday

Deer May Be Killed Starting Monday — Open Season on Ducks and Geese Begins Tuesday

The hunting season opens next week, all hunters having a lawful right to kill one male

deer with horns during the period from September 15 to October 15, inclusive. Ducks and geese may be killed from September 16 to December 16, inclusive. The bag limit on ducks and geese is 15 birds in any one day. Hunters are also

allowed to shoot grouse this year, but the season on these birds does not open until October 15, and lasts one month, with a bag limit per day of four birds.

Elk, deer, antelope, moose and game birds of all kinds

in the state have increased during the past year, and a general survey of game conditions shows fewer violations of the game laws, according to information issued from the office of Frank S. Smith, state game and fish commissioner.

Approximately five million trout of the fingerling size from the five state hatcheries will be planted this year.

A decided increase in the number of people interested in game conditions, together with activities of various

sportsmen's associations, have done much to benefit game and fish in the state. With proper supervision, conservation and protection, wild game should last for all time to come, according to the commissioner.
