NOTICE OF PUBLIC HEARING PLANNING AND ZONING COMMISSION ZONING CHANGE

In pursuant to Wyoming Code; notice is hereby given that a Public Hearing will be held by the Town of Saratoga Planning and Zoning Commission.

Purpose: The Town of Saratoga Planning and Zoning Commission has received an application for a zone change from Rodney Bennett. The petitioner is requesting his property be re-zoned from Light Industrial Zoning to Heavy Industrial Zoning. The purpose of the zone change is to operate the property as a gravel pit, to include the harvesting, storage and processing of materials.

Property Description:

The legal descriptions of the property are:

“That portion of the W2NW4 of Section 12, T17N, R84W, Carbon County, Wyoming lying Easterly of the Easterly right of way of the Saratoga and Encampment Railroad as described in Book 86, Page 557, Records of Carbon County, Wyoming.”

And
A parcel of land in the W¼NW¼ of Section 12, T17N, R84W, 6th P.M., Saratoga, Carbon County, Wyoming, more completely described as follows:

Beginning at a point on the East-West centerline of Section 12 which is the intersection with the Westerly right of way of the abandoned Wyoming Colorado Railroad, Inc., said point bears S89°05’56”E, 822.60 feet from the West ¼ corner of said Section 12; Thence S89°05’56”E, 102.05 feet along said East-West centerline of Section 12 to the intersection of the Easterly right of way of the abandoned Wyoming Colorado Railroad, Inc.; Thence following said Easterly right of way along the arc of a non tangent curve an arc distance of 712.99 feet on a radius of 11409.16 feet through a central angle of 3°34’50”, with a chord bearing and distance of N14°12’24”E, 712.87 feet; Thence N15°59’48”E, 675.54 feet along said Easterly right of way to a point; Thence N89°58’19”W, 104.02 feet to a point on said Westerly right of way; Thence S15°59’48”W, 646.92 feet along the Westerly right of way of the abandoned Wyoming Colorado Railroad, Inc., to the beginning of a tangent curve to the left; Thence following said Westerly right of way along the arc of said curve an arc distance of 739.60 feet on a radius of 11509.16 feet through a central angle of 3°40’55”, with a chord bearing and distance of S14°09’21”W, 739.47 feet to the point of beginning.

The property can generally be described as undeveloped land east of County Road 301, starting at the intersection of Chatterton Dr. and County Road 301, continuing north along the County Road 301 approximately 1000ft. Road/culvert work to temporarily close part of Forest Road 543 in the Snowy Range this fall

On-the ground barricades will mark the closure locations.

USDA – The southern portion of Forest Road 543 in the Snowy Range is temporarily closed due to road work/culvert replacement occurring throughout September and October. The road is in southeast Wyoming, on the Medicine Bow National Forest, just south of Rob Roy Reservoir and the community of Keystone.

An approximate 3.5-mile closure will be in place Sept. 2 – Oct. 31 with barricades at the junction of Forest Road 512 on the south end and Forest Road 542 on the north end. Private landowners in the area may access their property on the north end of the closure via the 542 Road.

The National Forest surrounding the closed road remains open for use and may be accessed by multiple alternate routes such as the 512 Road to the west.

Timing of the temporary closure coincides with seasonal low flow on Muddy Creek, which is the location of the culvert replacement.

The planned work will replace failing infrastructure, improve hydrologic function, increase flood capacity, and improve aquatic organism passage. The contract is being administered through a partnership with Trout Unlimited.

Short-term road closures provide long-term resource benefits and public safety.

Visitors should be aware of ongoing changes that may affect travel in the National Forest.

Those traveling through the National Forest should pay attention to signage and refer to Motor Vehicle Use Maps (MVUM) for details. MVUMs are free and may be obtained digitally.

Saratoga Police Department
